

Website user agreement on the processing of personal data

1. I hereby, hereinafter referred to as the "Personal Data Subject"/Participant, in pursuance of the requirements of Federal Law No. 152-FZ of July 27, 2006, No. 152-FZ "On Personal Data" (as amended) freely, of my own free will and in my own interest, give my agreement to R&C Market Research Company, hereinafter referred to as the "Organizer", to process my personal data specified during registration by filling out the event web form on the website <https://euras-forum.com/> (hereinafter referred to as the website) directed (completed) using the Website.

By providing the Organizer with my personal data, the "Personal Data Subject"/the Participant agrees to the transfer of personal data to third parties acting as partners/contractors of the Organizer in order to ensure the participation of the "Personal Data Subject"/Participant in the Organizer's events.

2. By personal data, I mean any information relating to me as a Personal Data Subject, including my last name, first name, patronymic, address, education, profession, contact information (phone, fax, email, postal address), photographs (participant's image), information about professional activities, login and password for access to the personal account, IP address of the participant's devices, history of all actions of the participant on the website. By the processing of personal data, I mean the collection, systematization, accumulation, clarification, updating, modification, use, distribution, transfer, including cross-border, depersonalization, blocking, destruction, indefinite storage and any other actions (operations) with personal data in accordance with Federal Law of July 27, 2006 No. 152-FZ "On Personal Data".

3. The processing of personal data of the Personal Data Subject is carried out solely for the purpose of registering the Personal Data Subject in the website database for his participation in the Event with the subsequent sending to the Personal Data Subject of mail messages, SMS notifications and newsletters, invitations to the Organizer's events and other information of advertising and news content, as well as in order to confirm the identity of the Personal Data Subject/Participant when attending the events of the Organizer.

4. The date of issue of consent to the processing of personal data of the Personal Data Subject is the date of sending the registration web form from the website <https://euras-forum.com/> and putting a tick on the website <https://euras-forum.com/>

5. The processing of personal data of the Personal Data Subject can be carried out using automation tools and/or without using automation tools in accordance with the current legislation of the Russian Federation and the internal regulations of the Organizer

6. The organizer takes the necessary legal, organizational and technical measures or ensures their adoption to protect personal data from unauthorized or accidental access to them, destruction, modification, blocking, copying, provision, dissemination of personal data, as well as from other illegal actions in relation to personal data, and also undertakes the obligation to maintain the confidentiality of the personal data of the Personal Data Subject/Participant.

7. I am aware that:

- this agreement to the processing of my personal data specified during registration on the Website, sent (filled in) using the Website, is valid for 20 (twenty) years from the date of registration on the Website.
- the agreement can be revoked by me on the basis of a written application in any form sent to the Organizer's e-mail sales@euras-forum.com;
- the provision of personal data of third parties without their agreement entails liability in accordance with the current legislation of the Russian Federation.
